The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 05 day of FEBRUARY, 2020

at approximately 10:00 PM, at 1220 MAIN STREET, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE THE VICTIM, HER BOYFRIEND AND CO-HABITANT, AGAINST THE WILL OF THE VICTIM, TO-WIT: SLAPPED THE VICTIM IN THE FACE AND SCRATCHED THE VICTIM IN MULTIPLE LOCATIONS..

THE DEFENDANT AND VICTIM WERE HAVING A VERBAL ARGUMENT OVER SOME COMMENTS MADE ABOUT EACH OTHERS FAMILIES. THE DEFENDANT TOOK OFFENSE TO WHAT THE VICTIM STATED AND SLAPPED THE VICTIM IN THE FACE. THE DEFENDANT CONTINUED TO ATTACK THE VICTIM CAUSING MULTIPLE SCRATCH MARKS ACROSS THE VICTIM'S FACE, TORSO, AND ARMS. DURING THE INVESTIGATION THE DEFENDANT MADE SPONTANEOUS STATEMENTS THAT SHE "SLAPPED THE SHIT OUT OF HIM". THE DEFENDANT ALSO STATED AS THE VICTIM WAS ATTEMPTING TO EXIT THE ROOM, THE DEFENDANT FOLLOWED THE VICTIM AND CONTINUED TO ATTACK THE VICTIM.

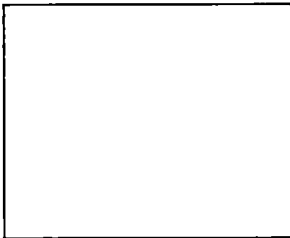
