PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.

On 05/28/21 at 0003hrs I observed a silver/black 2017 Range Rover (FL Tag #HVQN23) make a right turn eastbound from NE 2nd Ave. onto NE 1st St. The 200 block to the 500 block of NE 1st St. is configured with one westbound lane and one eastbound lane divided by a double yellow line. The Range Rover crossed the double yellow line and continued to travel eastbound on top of the double yellow line. An oncoming vehicle was traveling westbound and the Range Rover did not move off the double yellow line and caused the oncoming vehicle to move further toward the shoulder to avoid a motor vehicle crash. While in the 500 block of NE 1st St., the Range Rover entered a parking space and put the vehicle in park. I activated my emergency lights of my marked DBPD patrol vehicle to conduct a traffic stop. I met with the white female driver and identified her by her FL DL as Brook Rizpah Brittain. There was a white male in the passenger rear seat asleep. The vehicle engine was running and the vehicle key fob was in Brittain's possession.

OBSERVATION OF DRIVER:

When I approached the driver window, Brittain had her eyes closed and was moving very slowly. I knocked on the window signaling Brittain to roll the window down. Brittain repeatedly unlocked and locked the vehicle. After several attempts to roll the window down, Brittain opened the driver door. Brittain stated the window didn't work and I pressed the power window button showing her she was pressing the door lock buttons instead of the window button. I smelled an odor of an unknown alcoholic beverage coming from Brittain. Brittain's eyes were red and had a glassy appearance. Brittain spoke slowly and her speech was slurred. Brittain had slow response to my questions. After exiting the vehicle and walking back toward my patrol vehicle, I still smelled an odor of an unknown alcoholic beverage coming from Brittain. Brittain swayed while standing still. Brittain had difficulty remembering what we had talked about and repeated the same statement several times. During roadsides, Brittain stated she understood my instructions and before the roadside was completed she would state she did not understand.

DRIVER'S STATEMENTS:

Brittain stated the white male in the rear seat was her daughter's ex-boyfriend and he called her for a ride because he was intoxicated. Brittain stated she was at home all night prior to driving. Brittain stated she consumed two alcoholic beverages but did not state what kind of beverages she consumed. Brittain stated she finished her last alcoholic beverage one hour prior to the traffic stop. Brittain stated she went to Honey (16 E. Atlantic Ave., Delray Beach, FL 33444) to pickup the white male passenger. Brittain stated she went inside the bar for seven minutes and returned to her vehicle. Brittain stated she is prescribed Xanax but has not taken any for the past three days. Brittain repeatedly stated she was trying to do the right thing for her family. Brittain stated her daughter is a suffering drug addict and her ex-husband was physically abusive toward her.

ODORS:

I smelled a strong odor of an unknown alcoholic beverage coming from Brittain.

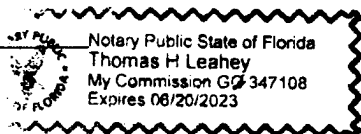

Other Observations:

Brittain swayed while standing still. Brittain stopped following the stylus light and had to be instructed several times to keep following the light with her eyes. Brittain asked if the blue stylus light could be shut off during the HGN/VGN roadside.

WALK & TURN:

Brittain swayed while standing still. During the instructional phase, Brittain did not follow instructions to place her feet heel to toe and instead placed her side by side. Brittain did not count as instructed while walking. Brittain did not touch heel to toe on any of her steps. Brittain used her arms for balance. Brittain asked how to turn around and how many steps to take while performing the roadside. Brittain did not turn around as instructed. Brittain did not walk 9 steps on either series of steps.

ONE LEG STAND:

Brittain swayed while standing still. During the instructional phase, Brittain lifted her leg up in several different ways without being instructed to start. After I told Brittain she could begin, Brittain began talking about her family and did not perform the roadside. Due to Brittain not following instructions, this roadside was not completed.

FINGER TO NOSE:

Brittain swayed while standing still. Brittain opened her eyes without being instructed to do so. Brittain missed the tip of her nose on several attempts.

ROMBERG ALPHABET:

Brittain swayed while standing still. Brittain recited the wrong letters on several letters often repeated the same letter. Brittain stopped reciting without reaching the end of the alphabet.

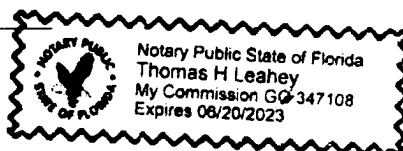



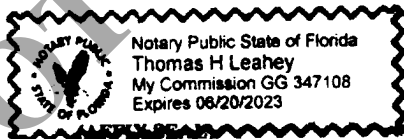
