The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a white 2010 Toyota 4-door (FL TAG:#IJ39NT) southbound on Armenia Av S in the left lane next to me, when she turned left (eastbound) onto Platt St W. While turning, she made a very wide left turn, drifted into my lane and cut me off (forcing me to brake to avoid an accident), then continued past my lane and into a bicycle lane. During a traffic stop for the infraction and suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, dilated pupils, droopy eyelids, blank/dazed stare, slurred speech, she was confused, appeared sleepy/lethargic, had fumbling fingers, moved with slow/deliberate movements, was in possession of 3 opened bottles of vodka, marijuana, 2 glass pipes (with marijuana residue) and several (7) bottles of pills, and emitted a distinct odor of an alcoholic beverage & marijuana from her breath & person. While checking her eyes (HGN), she displayed 6/6 HGN + VGN, then refused to continue with additional SFSEs. Based on the totality of the circumstances, the defendant was arrested for DUI. While attempting to handcuff her, she pulled away while screaming "NO!" and did not allow me to place the handcuffs on her. With the assistance of another officer, she was pinned against the vehicle to regain control and was eventually handcuffed. She remained defiant & physically resistant and had to be forcibly placed inside my vehicle to secure her. When asked if she would willingly provide a breath & urine sample, she did not answer me. I then read her Implied Consent at 2345 hours, and she refused. She has a prior suspension for refusal to submit to a breath test on 11/06/2018.
