My body worn camera was activated during this investigation.</p> <p>Upon arrival, I met with the caller who was identified via Florida driver license as Elizabeth Arrastia (DOB 6/10/1977). Arrastia gave a sworn statement advising she and Tiffany Hasson (victim DOB 3/11/1980) was in the efficiency behind the address listed above. Arrastia stated Hasson received a text from a neighbor by the name of Anthony and Hasson was going to check on him. Arrastia advised she and Hasson were walking out of the front door of the efficiency when a white female with blonde hair pulled the front door open and walked into the residence uninvited. Arrastia stated the blonde who was later identified as Brooke Roemer (DOB 1/3/1992) walked by her and into the kitchen area where Hasson was standing. Arrastia advised Roemer pushed Hasson causing her to fall to the floor in the kitchen and punched and kicked Hasson while she was on the floor. Arrastia stated as Roemer was attacking Hasson, Roemer was yelling stay away from my boyfriend. Arrastia advised that is when she called the police.</p> <p>I then made contact with Hasson who was on the floor when I arrived. Hasson was identified via Florida driver license. Hasson gave a sworn statement advising she was in the residence when she received a text message from an Anthony, unknown last name. Hasson advised Anthony is a neighbor that lives in the main residence and wanted to hangout, so she was going to his residence. Hasson advised as Arrastia opened the door, Roemer grabbed the door as Arrastia was walking out and walked into her residence and attacked her. Hasson stated as she was rushed by Roemer, she fell to the floor and Roemer continued to punch and kick her. Hasson said Roemer then left the residence. Hasson remained on the floor and stated she had pain in her neck. Hasson said she does not know Roemer and will prosecute.</p>

<p>I observe no physical injuries on Hasson. Palm Beach Gardens Fire Rescue responded to the scene to treat Hasson for her neck pain. Hasson was not transported to the Hospital. Hasson was given a Victim's Brochure.</p> <p>I then made contact with Roemer who was at the main address in front of the efficiency. Roemer refused to give a statement. At this point in time, Roemer was placed in handcuffs and detained. I asked Hasson if she remembered what Roemer looked like and if she would be able to identify her if she sees her again and she said yes. I walked Hasson outside where Roemer was located, and she identified Roemer as the blonde that attacked her. Roemer was placed under arrest and transported to Palm Beach Gardens Police Booking. Note* Anthony was not on scene.</p> <p>Based on the facts and circumstances, to include statements from all parties involved, I found Brooke Roemer to be the primary aggressor. There is probable cause to arrest Roemer for Burglary to a Dwelling Occupied F.S.S 810.02(3)(A) and Battery (Simple) F.S.S 784.03(1)(A)(1). Roemer was transported to Palm Beach County Jail without incident.</p>
