The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/08/2021, at approximately 0200 hours, the defendant and victim were laying in bed in the master bedroom of their shared residence located at 12321 Gilmerton Mist Ln, Florida, within Hillsborough County. The defendant and victim have been married for the past year, they have known each other since 2016, and have been living together for the past 2-3 years. The defendant kicked the victim on her body three or four times to try to get her out of bed. The defendant also pushed and punched the victim, which caused the victim's head to strike a dresser in the bedroom. The victim sustained a bruise on the back of her lower right calf, along with a bruise on the top of her arm by her elbow. The victim refused EMS treatment. All of the above listed actions were against the victim's will, and were unwanted. The victim positively identified the defendant as the person who committed this offense. The defendant was positively identified via his DAVID photograph as Bruce Anthony Curtis II.
