On March 18, 2021 at approximately 1:19 AM the Lake Worth Regional Communications Center dispatched me to a vehicle hit and run crash located at State Road 9 (Interstate 95) northbound south of Palm Beach Lakes Blvd. LWRCC advised there was an off-duty Delray Beach police unit that witnessed a gray sedan hit another vehicle and continued to travel northbound on State Road 9. The Delray Beach unit was able to follow the suspect vehicle and conduct a traffic stop on the vehicle. When I arrived on scene, the suspect vehicle, a silver Porsche (Florida Tag: L78GU) was located on the right outside shoulder. The Porsche had front bumper damage as if it were involved in prior crash. I was able to locate the driver of the silver Porsche and identified him as Bruno C Maldonado through his Florida driver license: M435-063-85-377-0. I proceeded to conduct my crash investigation and began to ask Mr. Maldonado what happened during the crash. Mr. Maldonado advised me that he no recollection of being involved in a crash. As I spoke with Mr. Maldonado, I immediately detected the odor of an unknown alcoholic beverage was emitting from his breath as he talked. I also observed the driver's blood shot watery eyes and slurred speech. Based on my observations, I proceeded to have Mr. Maldonado exit the vehicle and walk to the front of my patrol vehicle. Since the victim of the crash never contacted our LWRCC to report a crash, I informed Mr. Maldonado that I was finished conducting the crash investigation and I was beginning a criminal investigation for DUI. Mr. Maldonado agreed to Voluntary perform the Field Sobriety Exercises.

FSEs were conducted on the right outside shoulder of State Road 9. The ground was free of debris and a red-light pen was used as a stimulus for the Horizontal Gaze Nystagmus. A white chalked line was used for the Walk and Turn. Before beginning the exercises, I checked to see if Mr. Maldonado was wearing glasses. It was determined that Mr. Maldonado was not wearing glasses. Mr. Maldonado was instructed to place his feet together and place his hands down at his side. He then was instructed to keep his head still and follow the stimulus with his eyes and his eyes only. He was also instructed to keep looking at the stimulus until told not to. Mr. Maldonado verbally indicated that he understood all the instructions above.

Horizontal Gaze Nystagmus:

- Equal tracking and equal pupil size.
- During the exercise I observed the defendant with lack of pursuit in both eyes.

- Distinct and sustained nystagmus at maximum deviation in Both eyes
- Nystagmus prior to 45 degrees in both eyes

Walk and Turn:

The defendant advised he understood the instructions explained.

During the walk and turn I observed

- Unable to maintain balance in the beginning of the exercise
- Driver performed 9 steps forward missing several heel to toe and an improper turn
- Driver used arms for balance
- Driver lost balance during turn

One Leg Stand:

The defendant advised he understood the instructions explained.

During the one leg Stand I observed

- The driver lifted his right foot off the ground
- Driver did not count out loud
- Driver looked up throughout the whole exercise
- Driver put foot down before being told to stop

Due to the totality of circumstances, Mr. Maldonado was placed under arrest for DUI at 1:47 A.M and was transported to the Palm Beach County Breath test center. Once I arrived, I conducted a 20-minute observation. At no time did he regurgitate or take anything by mouth. I then requested that he provide a sample of his breath which he refused. Florida Implied consent was read, and he refused. Mr. Maldonado was booked at the Palm Beach County Jail.

The above incident occurred in Palm Beach County.




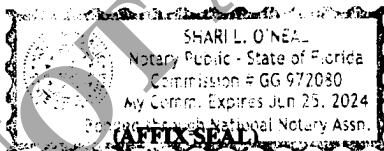
