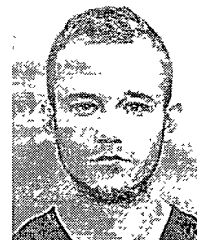

Probable Cause Affidavit

Before me this date personally appeared HALL, ROGER R. (18378) who being first duly sworn deposes and says that on 8 day of May, (year) 2017 at 4600 HILLSBORO BLVD, CC, FL 33073 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Upon making contact with the driver and sole occupant/defendant, Bryan Cerasani (24 YOA) I requested the defendant's license and the vehicle's documents. The defendant handed me his FL driver's license and the vehicles documents. I was wearing my tactical vest with "POLICE" written across the front and back in large gray lettering. Upon speaking to the defendant, I could smell the odor of cannabis emitting from the inside of his vehicle. I advised the defendant of what I smelled and asked him if he has any weapons or contraband (drugs) on his person or anywhere inside the vehicle stated "no, but maybe there's some shake on the floor from the rolling loud concert this weekend." I then advised the defendant that I would be searching him and the vehicle based on the odor of cannabis coming from the vehicle. I then conducted a search of the defendant's person and the vehicle. The search the defendant's person was negative. Upon searching the vehicle, I located a medium size Ziploc baggie on the floor behind the passenger seat inside a green bag containing marijuana. I also located a brown grocery bag, which contained two (2) medium size Ziploc baggie completely full also containing marijuana. Upon locating the cannabis the defendant spontaneously uttered, "The marijuana is not mine, I'm just holding it for a friend." I field tested the cannabis using nacro test #8, it tested positive for cannabis. The defendant was arrested for Possession of Cannabis over 20 Grams (225.2 grams) and disobey stop light, he was issued (CK17-0396) and he was later TOT BSO.
