The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 3/19/21 at approximately 0251 hrs, I observed the defendant driving a gold Land Rover bearing FL tag #NEPJ35, traveling west on 4th Av from 17th St N. Between 16th St and 15th St, the defendant was driving over the double yellow lane lines, into oncoming traffic for about one block. The defendant then drove off of the roadway and swerved back into the correct lane, on 4th Av approaching Nuccio. The defendant exhibited clues of impairment during SFSTs and was taken into custody. It should be noted, post arrest, and after the performance of SFSTs, the defendant provided breath samples of 0.164 and 0.184. The defendant was positively identified via his FL DL.
