
**ADVISORY AND SOLVENCY HEARING**

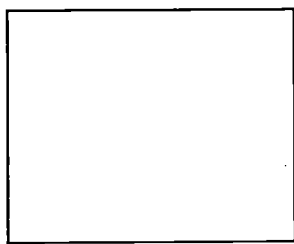
