On February 22, 2021 at approximately at 2255 hours I observed a White chevy trailblazer bearing the Florida Tag of Z782VB driving southbound On Prosperity Farms Rd. North Palm Beach FL, 33408. The vehicle was following too close within a foot of the vehicle in front of it and almost rear ended another vehicle and forcing the vehicle off the road. I turned my marked North Palm Beach Police patrol vehicle around and conducted a traffic stop on the vehicle. Upon running the vehicle registration information through North County Dispatch, the vehicle was registered to Camilo Yepes (W/M DOB: 06/28/1988).

The vehicle came to a complete stop at the Shell Gas station location at 9009 Prosperity Farms Rd. in North Palm Beach FL, 33408. Upon making contact with Yepes, he became verbally aggressive and had slurred speech and red glassy eyes and the odor of an unknown alcoholic beverage became stronger as he spoke. Yepes advised he was on his way home from the bar.

Based on Yepes's driving pattern, obvious signs of impairment, and admission to consuming alcohol, I requested Police Officer Perez to respond to the scene to conduct a driving under the influence investigation. The subsequent investigation was turned over to Police Officer Perez. Yepes was issued a traffic citation for following too closely (AD22PNE).

On the 23 day of February, 2021 at 01:54 (Specifically include facts constituting cause for arrest.)

On Monday, February 22, 2021 at approximately 10:54PM I responded to Police Officer James Wright's traffic stop located at the intersection of Northlake Blvd and Prosperity Farms Rd, North Palm Beach, FL 33408. The vehicle came to a complete stop at 9009 Prosperity Farms Rd. See Police Officer James Wright supplement.

Upon my arrival, I made contact with Camilo A Yepes 08/28/1988 who was identified by his Florida driver's license. I introduced myself as Police Officer Perez with the North Palm Beach Police Department and immediately upon making contact with Yepes, I was able to detect an odor of an unknown alcoholic beverage emanating from his person. While speaking with Yepes I observed his speech was slurred and his eyes appeared to be glossy/ watery. I then asked for Yepes to step out of the vehicle and explained to him that I am now conducting a Driving Under the Influence investigation (DUI) due to his signs of impairment.



When I asked Yepes where he was coming from he replied with "The Snuggery" which is a local bar located in Palm Beach Gardens, FL. When asked how much he had to drink he stated he had 3 alcoholic beverages at The Snuggery.

I then asked Yepes if he had any medical issues to include diabetes and he said no. He denied being under the direction of a medical doctor, any traumatic injuries that could not allow him to perform tasks, and denied having a prescription for glasses. I asked Yepes if he would consent to conducting Standardized Field Sobriety Tasks (SFST's) and he said "yes".

It should be noted, Yepes was instructed and demonstrated on all tasks which he acknowledged and understood all instructions.

During my investigation, on the Horizontal Gaze Nystagmus task I observed Yepes have:

He was placed in the back of my marked patrol vehicle and secured properly. He was transported to the PBSO Breath Alcohol Testing Center (BAT) where he became continuously verbally uncooperative with BAT staff and myself. It took multiple attempts for Yepes to follow instructions and continuously shouted over the BAT personnel. He was observed for 20 minutes and did not consume or regurgitate anything.</p>

Yepes was later turned over to PBSO where he was booked and processed.

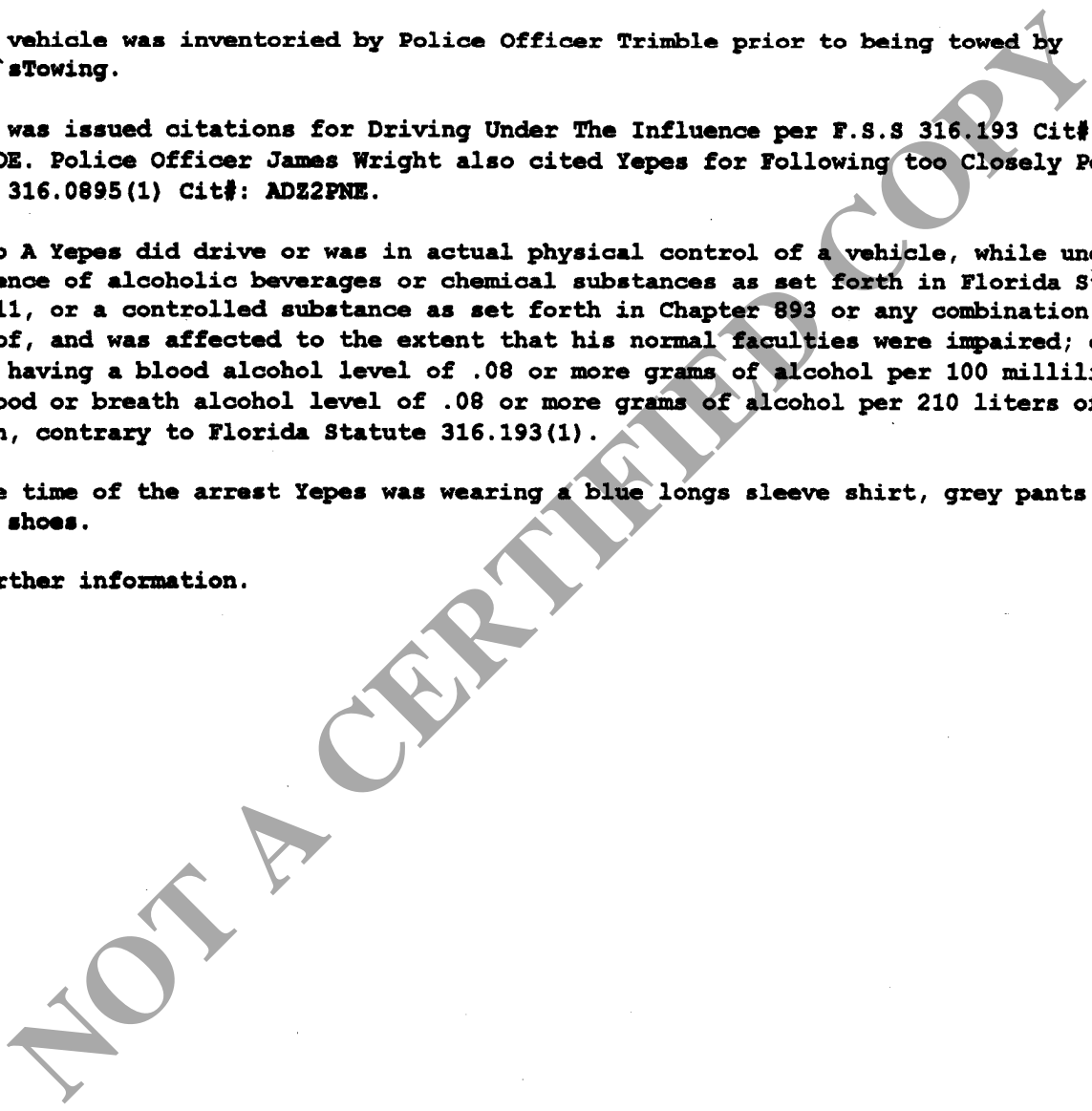
Yepes vehicle was inventoried by Police Officer Trimble prior to being towed by Kauff's Towing.




Yepes was issued citations for Driving Under The Influence per F.S.S 316.193 Cit#: ADZ2POE. Police Officer James Wright also cited Yepes for Following too Closely Per F.S.S 316.0895(1) Cit#: ADZ2PNE.

Camilo A Yepes did drive or was in actual physical control of a vehicle, while under the influence of alcoholic beverages or chemical substances as set forth in Florida Statute 877.111, or a controlled substance as set forth in Chapter 893 or any combination thereof, and was affected to the extent that his normal faculties were impaired; or while having a blood alcohol level of .08 or more grams of alcohol per 100 milliliters of blood or breath alcohol level of .08 or more grams of alcohol per 210 liters of breath, contrary to Florida Statute 316.193(1).

At the time of the arrest Yepes was wearing a blue long sleeve shirt, grey pants and black shoes.

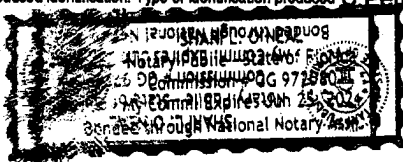

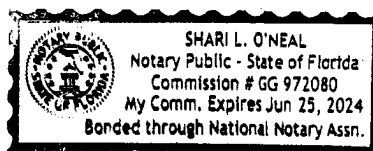

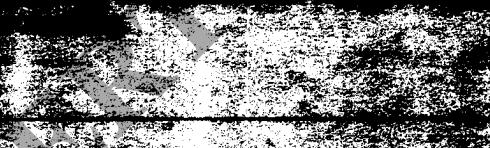
