The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a gray 2019 Mazda SUV bearing a Florida license plate of LSIB62. She was traveling north on N Howard Ave near W Kennedy Blvd and was weaving back and forth and failing to maintain a single lane. The defendant also weaved out of her lane and almost struck a vehicle driving next to her. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, fumbling fingers, inconsistent statements, a strong odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol just prior to driving. The defendant performed poorly on SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her FL DL.
