The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 7/11/2020, at approximately 2204 hours, at Knights Griffin Rd W / Deshong Dr, Plant City, FL 33565, Deputy Duncan (ABN 31838) made contact with the defendant, who he observed in actual physical control of her vehicle, a black Ford (bearing FL tag IHSU59 / VIN: 1FMJK1K53BEF26945), after the complainant observed the defendant traveling eastbound in the westbound lanes on Knights Griffin Rd. Deputy Duncan observed the defendant to have slurred speech and poor dexterity. Based on the observed indicators of impairment, Deputy Duncan requested a DUI investigator respond to the scene. Upon my arrival, I observed the same indicators of impairment listed above, as well as observed the defendant struggle to maintain her balance as she exited the vehicle, and detected the odor of an alcoholic beverage emitting from her breath. Post Miranda, the defendant admitted to recently consuming approximately 3 beers. The defendant was given the opportunity to perform field sobriety exercises, which she did poorly, indicating impairment. Subsequent to arrest, the defendant provided breath samples of .183/177 after a twenty minute observation period. The defendant was identified via their Florida driver's license (B000102637670).
