The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a black 2018 Hyundai Accent, 4 door, Florida tag AQWK53. The defendant followed another vehicle too closely in an exit/on-ramp from one interstate to another, and then passed this vehicle by pulling into a painted safety median/zone. The defendant accelerated to a very high rate of speed, which was visually estimated and patrol car paced (TPD DUI unit 5153) in excess of 100 MPH in a properly posted 55 MPH speed limit. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant wore two paper bar bands on her right wrist (one green and one white with orange hand prints), and also had multiple bar admissions ink stamps on the back of her left hand. The defendant's eyes were bloodshot and watery, and her face was flushed. The defendant stated that she drank two Vodka drinks tonight. The defendant was easily distracted, had difficulty focusing on the tasks that were presented to her, and she was forgetful as to what had been asked of her. The defendant swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant refused to submit to a lawful test of her breath after being advised of the Implied Consent Warnings. The defendant was positively identified by her FL DL.
