On March 29, 2022, I was assigned a sexual battery investigation. On 3/28/2022, the victim came to the Boca Raton Police Department to report a delayed sexual battery against [REDACTED] Carlisle Kirkpatrick. The following is a synopsis of her initial statement with Officer Desiderato. The victim stated she resides at [REDACTED] Carlisle, whom she has been married to since December of 2008. Also [REDACTED] the residence are [REDACTED] The victim became aware of incidents that "scared her", specifically stating she began observing sediment at the bottom of her alcoholic drinks on numerous occasions when she would drink alcohol in social settings. When she asked Carlisle about the sediment, he stated the sediment was Xanax he put in her drink to help her "chill out". The victim stated [REDACTED] began to slow, and eventually stopped, due to these suspicious incidents involving [REDACTED] In August 2021, the victim stated she observed a camera facing the bed she [REDACTED] Carlisle at [REDACTED] in Boca Raton. Because a camera is not normally facing the bed, the victim became suspicious and retrieved the ScanDisk memory card from the camera. She located a recorded video clip on the memory card. Shown in the video was non-consensual sexual intercourse between the victim who was unconscious and Carlisle. The victim does not recall, nor did she consent to the sexual intercourse. Shortly after viewing that video, the victim hired an attorney and stated she attempted to be more cognizant of her surroundings, however she located two more videos on Carlisle's personal cell phone and computer. The two videos, the victim believes, were made in November and December of 2021 depicting similar incidents involving "rough" non-consensual sexual intercourse where she was not conscious in the bedroom of [REDACTED]

On 12/06/2021, after locating the additional video clips, the victim confronted Carlisle and requested he immediately [REDACTED] the residence. Carlisle [REDACTED] belongings, purchased a Recreational Vehicle where he now resides at which is his company warehouse in Deerfield Beach (1717 SW 1st Way, Unit 11). At the end of December 2021, the victim stated she underwent a Date Rape Drug Test at a medical facility where a hair follicle test was administered. In January of 2022, the victim received results that her hair follicles tested positive for Ketamine. The victim stated she does not take Ketamine either by prescription or recreationally. The test results were loaded onto her ScanDisk memory card, along with video clips she obtained of the non-consensual sexual encounter, which was submitted into BRPD evidence. In addition, at some point last year, the victim located a metal lock box in the bedroom [REDACTED] Carlisle, which she was able to open. Inside the lock box were several vials of an unknown clear liquid, pain pills (labeled for Judy Kirkpatrick- Carlisle's deceased mom). When asked, the victim stated the lock box was no longer at her residence, so she was unable to provide it to officers or detectives. The lock box was a silver Honeywell lock box. The victim was able to video the contents which was provided in the ScanDisk memory card she provided to police. The victim stated Carlisle has since acknowledged and admitted to her he administered narcotics without her knowledge and subsequently had sexual intercourse with her, however the victim declined to notify police because she wished to try and help Carlisle get psychological help. On 03/28/2022, the victim was contacted by [REDACTED] school teacher from [REDACTED] regarding what the teacher believed was odd child behavior. When asked what the odd behavior was, the teacher explained that [REDACTED] asked three male classmates to pull their pants down and made attempts to peek under occupied bathroom stalls. Upon returning home at approximately 1600 hours, the victim asked [REDACTED] why he wanted to observe other classmates, to which he stated [REDACTED]. The victim further asked [REDACTED] if [REDACTED] asked to pull his pants down, to which [REDACTED] answered "yes", and added Carlisle "touches my bottom". The victim further asked [REDACTED] "Does he put his finger where poop comes out", and [REDACTED] responded "yes", and "ask him to stop". On 3/29/2022, I contacted Palm Beach County's Victim Services to have a victim advocate present during my interview with the victim. The interview was scheduled for 1300 hours. Present during the interview was Detective Hanley and the victim Advocate Ronnie Barker. The following is a synopsis of my sworn interview with the victim which took place at the Boca Raton Police Station. The interview was audio/video recorded and marked for evidence.

The victim provided me a similar statement as to the one she provided Officer Desiderato. The victim [REDACTED] Carlisle since 2008. Over the past few years, the victim has suspected that Carlisle has been drugging her on multiple occasions when they have gone out for the night. The victim wakes up the next morning and can't remember the night before. She has suspected that he has been drugging her drinks but could not prove it. In 2013 she noticed a nude picture of herself on his phone. The picture was of her sleeping, and she was unaware the picture was taken. Sometime in 2017 she noticed her drink had white sediment at the bottom. When she asked Carlisle about it, he said he put alprazolam in her drink so she would "chill out". The victim is prescribed alprazolam medication. In May of 2021, the victim noticed a camera in [REDACTED] bedroom that was pointed in the direction of [REDACTED] bed. The victim took the memory card from the camera to see what type of content the memory card had. The victim observed a video of herself unconscious on the bed, while Carlisle had vaginal intercourse with her. The video was filmed in [REDACTED] bedroom. The victim had no recollection of this happening. The victim observed numerous videos on the memory card of Carlisle having vaginal intercourse with her on separate occasions while she was unconscious. The victim can't remember any of these incidents and believes that Carlisle drugged her which is why she was unresponsive and could not remember the sexual intercourse. The victim and Carlisle discussed his sexual problems. The victim wanted to get Carlisle psychosexual therapy before going to law enforcement. The victim had other incidents where she would only drink 2 alcoholic drinks and completely blackout. At this point she suspected that Carlisle was continuing to drug her. She then went looking at his phones and saw other videos of him having sex with her unconscious against her will. The phones that contained the videos were a black iPhone and a white iPhone. The victim used her phone to record the videos off Carlisle's phones which she gave to law enforcement. The victim described Carlisle as being very knowledgeable in the field of computers. The victim believes that Carlisle recorded her on numerous other occasions using a digital camera, iPhone, and/or iPad which he then transferred to other storage devices which she has yet to locate. In all the videos, the victim was able to positively identify herself as the unconscious female and Carlisle as the male in the videos. All of the videos the victim identified the location as [REDACTED] bedroom at [REDACTED] house in Boca Raton [REDACTED]. I reviewed the videos that were on the ScanDisk Memory Card that the victim provided. The following is a synopsis of the videos.

There are 6 separate videos that show Carlisle having vaginal sexual intercourse with the victim on 6 separate occasions. In all of the videos the victim is unconscious and appears to be heavily sedated. In some of the videos the victim does wake up briefly and tells Carlisle to stop and get off. Carlisle continues to have sexual intercourse with the victim as she falls back into unconsciousness. In one of the videos, Carlisle is choking the victim with his hand around her neck, and Carlisle is squeezing so hard his knuckles are turning white. One of the videos, Carlisle has a belt around the victim's neck and grabs the belt in a choking manner while having sexual intercourse with her. It should be noted that Carlisle appears to be very stealth like in the videos, moving in a slow manner as to not wake up the victim. It should also be noted that the victim advised that they never have "rough" sex. The victim described [REDACTED] life as "plain". She would never consent to a belt around her neck or this type of sexual intercourse. Based on my investigation and the above information probable cause exist to charge Carlisle Kirkpatrick with 6 counts of Sexual Battery (helpless person 18 years or older) contrary to F.S.S 794.011(4) (b) and (e)1 and 6 counts of Video Voyeurism contrary to F.S.S 810.145 (1) (2) and (6) (b) .
