The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 On 02/22/2019, at approximately 2139 hours, at Lumsden Rd W / Heather Lakes Bl, Brandon, FL 33511, deputies responded to a traffic crash with injuries (see DHSMV traffic crash report #87715881). Upon arrival, Deputy Suarez #247321 made contact with the defendant, who was standing outside of her 2015 black Volkswagen Passat (FL tag: EDJL16 / VIN: 1VWBT7A33FC052602). The witness was involved in the traffic crash and assisted the defendant out of the driver's seat of her vehicle. Deputy Suarez observed indicators of impairment while speaking to the defendant. The indicators included bloodshot watery eyes, minor slurred speech, the odor of an alcoholic beverage on her breath, and her inability to answer questions without veering off task. I responded to the incident scene and advised her the traffic crash investigation has now concluded and I would be conducting a DUI criminal investigation. I explained to the defendant the indicators of impairment that were observed, and requested for her to submit to a series of field sobriety exercises. During the exercises, further indicators of impairment were observed and the defendant was arrested for DUI. A strong odor of alcoholic beverage could be smelled as I approached the driver's door of the above listed, where I observed three, twelve ounce cans of Jai Alai beer. Two were located in the passenger floorboard and one appeared open near the center cup holder, and was cold to the touch. While at CBT, I read the defendant the Implied Consent Warning, verbatim, in room #1, at which time she advised she understood and refused to submit to testing by stating, "I refuse." A query of DAVID revealed the defendant has had one prior refusal to submit to a lawful test of her breath, urine, or blood. The defendant was positively identified via her DAVID photograph.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
