<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 09/10/2021, at approximately 2348 hours, the defendant and victim were located inside their shared residence at 1104 Valladolid De Avila, Tampa, Fl 33613. The victim was asleep in the master bedroom when the defendant entered the room and sat on the victim's face. The victim told her to get off, and she began striking the victim repeatedly to his face. In an attempt to remove the defendant off his body, the victim grabbed her by the throat with one hand and shoved her. The defendant and victim fell to the ground, and the defendant continued throwing strikes with her hands and feet. The defendant then grabbed the victim's testicles and twisted them. The victim sustained the following injuries: swelling and redness to his left and right under eye areas, redness to his chest, and an abrasion to his left knee. The defendant and victim have been engaged in a dating relationship for approximately four years. They have been living together as a family for approximately two and a half years. The victim identified the defendant as the one who committed the offense. The defendant's identity was confirmed via her Florida driver's license.</p>
