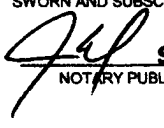

The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. The Person taken into custody . . . ☒ committed the below acts in my presence. ☐ was observed by _____ who told _____ that he/she saw the arrested person commit the below acts. ☐ confessed to _____ admitting to the below facts. ☒ was found to have committed the below acts, resulting from my (described) investigation. On the <u>9</u> day of <u>May</u>, <u>2022</u> at <u>19:40</u> (Specifically include facts constituting cause for arrest.) On 5/9/2022 at 1924 hours, I was driving N/B on NW 2nd Ave just north of the 4000 block. I was traveling approximately the speed limit of 35 mph in the inside lane of travel when I observed a large white truck accelerate toward the rear of the vehicle at a fast pace. The white truck was so close to my rear end that I could only see the lights and grill. The truck began flashing its headlights at the rear of my unmarked patrol vehicle and following so closely that I was in fear he was going to ram my rear end with his vehicle. The white truck was purposefully and with wanton disregard for persons or property so close to my rear that If I were to brake at all he would have collided into me. I continued to travel at approximately the speed limit and once there was an opening in the outside lane the truck accelerated quickly and began merging into my lane of travel to my right side. If I did not slow down I would have been forced into the median. As I slowed down, the driver, later identified by his FL DL as W/M Cary Bartlett rolled his windows down and began screaming and flailing his arms toward me in an aggressive manor while he drove just slightly ahead of me and into my lane of travel so that my vehicle was at the driver's side of his vehicle and the driver had a view straight into my windshield. Fear Bartlett may have a weapon, I quickly slowed down to attempt to get behind him, but there were other vehicles behind me also being disrupted by Bartlett's sporadic driving patterns. Once I was safely able to get behind the white truck, based on Bartlett's aggressive driving action's, wanton disregard for person's and property on the roadway including mine and other drivers, Bartlett following too closely, and failure to maintain a single lane while driving recklessly toward my vehicle in an attempt to push my vehicle into the median, I conducted a traffic stop on the white truck bearing FL tag "LJYH88". Bartlett pulled over very slowly, unlike a standard traffic stop, and slowly rolled toward the rear of 4805 NW 2nd Ave behind a business building off of the main roadway (NW 2nd Ave), as if to hide the traffic stop from the main throughfare. noted that I observed back up Officers pass me in an attempt to locate me for assistance.

As Bartlett finally stopped after a extended time rolling he quickly jumped out of the vehicle. I gave him loud verbal commands to get back into to vehicle and he continued to flail and scream toward me. I had to give Bartlett numerous loud verbal commands to get back into his vehicle and shut the door. Bartlett continued to disregard my lawful orders and reach into the vehicle then jump in and out and refused to close the door with him inside. I even explained to Bartlett that if he did not comply with my orders during my lawful traffic stop which was interfering with my investigation he would be arrested for obstruction.

Officer Cox arrived and we completed a felony stop and ordered Bartlett back to our police vehicle. Bartlett refused to face away from police as he was walking back after being ordered to multiple times. He was finally placed into handcuffs and arrested for reckless driving pursuant to FSS 316.192(1a), and resisting without violence pursuant to FSS 843.02. I issued Bartlett a citation for reckless driving, following to closely, failure to maintain a single lane, and open container (Miller Lite Beer) located during inventory search in the center console. It was open, cold and about half full, and accompanied by another unopened cold beer and two empties.

Bartlett was issued a notice to appear for his resisting charge, and a traffic court date and citation for his traffic charges. His vehicle was towed by Westway and officers on scene completed a two slip.
