The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a black 2007 Mercedes, 4 door, Florida temporary tag CWN8300. The defendant stopped well beyond a painted white stop line at a steady red traffic light so that the vehicle was completely beyond the stop line and was into and blocking the clearly marked pedestrian crossing. The defendant then stopped for a second steady red traffic light, however, she did not wait for the light to cycle to green and proceeded into the intersection against the steady red traffic light. A traffic stop was conducted. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and she was forgetful as related to documents that were requested. The defendant had difficulty recalling her home address. The defendant wore a purple and white paper bar admissions band on her right wrist. The defendant stated she drank one and a half alcoholic beverages tonight. The defendant swayed while standing. Approximately 2 grams of marijuana and 3 1/2 marijuana cigarettes were found in the defendants vehicle and in her purse. The defendant admitted to smoking "a blunt" earlier tonight. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment. Based on a totality of the circumstances, the defendant was arrested for DUI. Defendant provided breath samples of .048 and .049, and provided a urine sample. The defendant was positively identified by her Florida DL.
