The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 12 day of FEBRUARY, 2020,

at approximately 3:03 AM, at 3RD ST/GULF BLVD, BELLEAIR BEACH FL, in Pinellas County did:

THEN AND THERE UNLAWFULLY HAVE IN HER POSSESSION, CUSTODY, OR CONTROL A CERTAIN CONTROLLED SUBSTANCE, TO-WIT: CANNABIS SATIVA, COMMONLY KNOWN AS MARIJUANA.

AFTER CONDUCTING A TRAFFIC STOP ON THE VEHICLE BEARING THE FLORIDA PLATE LCTD62, THE DEFENDANT GAVE ME VERBAL CONSENT TO SEARCH THE VEHICLE AND IMMEDIATELY STATED SHE HAD MARIJUANA IN THE DRIVER SIDE DOOR THAT SHE ADMITTED WAS HERS. I FOUND THREE (3) SEPARATE CLEAR PLASTIC BAGS CONTAINING GREEN LEAFY SUBSTANCE WHICH BASED OFF OF MY TRAINING AND EXPERIENCE WAS KNOWN AS MARIJUANA. A PRESUMPTIVE FIELD TEST WAS CONDUCTED ON THE GREEN LEAFY SUBSTANCE AND TESTED POSITIVE FOR MARIJUANA. THE WEIGHT OF ALL THREE (3) BAGS TOTALED 23 GRAMS. THE DEFENDANT SPONTANEOUSLY STATED SHE BELIEVED THE AMOUNT OF MARIJUANA WOULD TOTAL 22 GRAMS AND ASSUMED IT WAS A MISDEMEANOR.
