The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did I observed the defendant a white Hyundai with TX tag MTV9628 on the roadway. She was traveling West on W. Kennedy Blvd towards West Shore Blvd at a high rate of speed that I estimated to be approximately 75 miles per hour in a 45 mile per hour zone. I got behind her and she continued to accelerate to over 80 miles per hour in a 50 mile per hour zone. I conducted a traffic stop and made contact with the defendant who was the driver and only occupant of the vehicle. Upon contact I could smell the odor of alcoholic beverages from her breath. Her eyes were glassy and bloodshot. She performed field sobriety exercises and showed impairment. Her breath alcohol content was .240 / .239.
