On the 28 day of March, 2022 at 17:55 (Specifically include facts constituting cause for arrest.) On Monday, March 28th, 2022, at approximately 5:55pm I was dispatched to the area of Northlake Blvd and Military Trail, Palm Beach Gardens, Palm Beach County, Florida in reference to a traffic crash involving a white BMW and Gray Kia. My department issued body worn camera was activated throughout the duration of this incident. I was able to locate the gray Kia Soul (FL Tag: ETZM95) stopped in the left through lane of southbound Military Trail, approximately 180 feet (ft) south of South Mary Circle. Officer Johnston (ID #451) and I made contact with registered owner of the Kia Soul, Catherine M. Minera (W/F DOB: 05/07/1995) who was standing outside of the gray Kia. Based off of where the crash occurred, Police Dispatch notified the Palm Beach County Sheriffs (PBSO) due to the crash occurring in their jurisdiction. (PBSO Case #22-050881). Also, while conversing with Minera, she was visibly upset and crying. Minera also exhibited signs of impairment to include bloodshot water eyes, slurred speech, and I could smell the odor of an unknown alcoholic beverage emanating from her person. While waiting for PBSO to arrive, Minera had to be repeatedly told to stop walking away and to stay near her vehicle while being difficult with Officers. Officers were doing this based off of our observations for her safety so she would not walk into the busy roadway. PBSO arrived on scene approximately thirty (30) minutes later to conduct their traffic investigation. Officer Johnston and I stood by with the Deputy due to the above observations. The Deputy gathered basic information from Minera and walked away. Minera suddenly proceeded to take off her shirt exposing her brassier. Minera then began walking northbound on the median where Officer Johnston had to physically guide her back toward her vehicle to sit on the curb. Shortly after, Minera got up again while on the phone and ignored my commands to sit back down. Minera told me

	This process continued four (4) more times before Officer Johnston and I went to place her in handcuffs. Minera was informed she was not under arrest at this time but being detained. Once I was able to secure Minera in handcuffs and proceeded to double lock them, Minera kicked her right leg back, striking my groin/genital area with her right leg. Once this occurred Officer Johnston and I proceeded to walk Minera to my marked Palm Beach Gardens Police vehicle (#19427).						
	Minera continued to resist Officers when they tried to get her into the back seat of the Police vehicle. When Officers told Minera to get in the vehicle she stated, "No hold the fuck on, don't be an asshole." Minera proceeded to call Officer Johnston and I "rookies" before screaming at me "you fucking whore, pussy ass god damn whore." Minera also Minera continued to kick her legs out and was pulling away from the backseat area.						
	Once I arrived at the Palm Beach Gardens Police Department Minera repeatedly attempted to kick out the window of my Police vehicle out while calling me a "piece of shit." Based on the totality of the circumstances I find probable cause to charge Minera with the following:
