The defendant, Cecilia Paz Tobar Manriquez, was operating a white Volkswagon (Tag IE98AR) westbound on Okechobee Boulevard at the intersection with the Florida Turnpike, West Palm Beach, Palm Beach County, Florida. She drove through the chevron painted markings on the roadway (violation of a traffic control device), cut me off, requiring me to apply a hard braking input to avoid a motor vehicle crash with the front of my unmarked Palm Beach County Sheriff's Office vehicle. I conducted a traffic stop and identified the defendant by her Chile identification card, as Tobar Manriquez. As the driver only spoke Spanish and I only speak English, via the language line translation, the defendant argued she didn't do anything wrong and that I didn't have a purpose for stopping her. She admitted to not having a valid driver license from any state in the USA. She was unable to explain who the registered owner of the vehicle and claimed she "rented" the car like she always does when she visits this country and driving without a license has never been a problem before.

I made contact with the registered owner of the vehicle via telephone who advised his vehicle went "missing" three weeks ago and that his friend was supposed to bring him back the car but has not returned yet. He informed me he would respond to the scene and retrieve his car.

Through language line, the interpreter instructed Tobar Manriquez to turn off the car, turn the keys over to me, and exit the vehicle. She refused. This happened two more times with language line instructing the driver to give me the keys and exit the vehicle to which the driver argued against the commands each time. I opened the passenger door and reached over the juvenile passenger and into the vehicle to remove the key from the ignition. Tobar Manriquez struck my hand and said "No". Once I obtained the key, I unbuckled the juvenile from the front passenger seat and instructed her to exit. She refused and said no and began to lean deep into the inside of the car indicating refusal. I grabbed the passengers right arm and assisted her out of the car. I then went to the driver side and opened the vehicle door. The driver was on the phone and was ignoring my verbal commands to exit the vehicle. She ignored me each time and continued her phone conversation. I reached in and unbuckled the drivers seat belt. She grabbed my hands and attempted to stop me. I then grabbed the back of the drivers head by her hair with one hand and grabbed her arm with my other hand and assisted her out of the car. She was arrested for battery on a law enforcement officer, pursuant to FSS 784.07(28) and booked into the county jail.
