PERSONAL CONTACT

DRIVING PATTERN: (Actual Physical Control; Physical Evidence or Statements Putting Defendant Behind Wheel of Vehicle)

On 05/29/2021 at approximately 0215 hours, This Officer was conducting a traffic enforcement selective in the area of ALT A1A and N Entrada Way, PBG, FL, when a vehicle was observed traveling at an increased rate of speed north bound in the inside through lane. Body worn camera and in car video were used. This Officer's initial visual estimation of the vehicle, was approximately 60 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR21 (DB001317), forward antenna (KC086606) this Officer received a steady tone and reading of 60 MPH. The RADAR calibration was last checked on 05/27/2021 and was due on 11/27/2021. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, MN. This Officer entered the same lane behind the vehicle and initiated a traffic stop on the vehicle, an Orange Infiniti utility vehicle (2804XB/FL) on Alt A1A just north of Legacy Av, PBG, FL. This Officer made contact with the driver and sole occupant, identified via Florida Driver License photo, Celeste Neves, while she was still in the driver seat.

OBSERVATION OF DRIVER:

Neves had bloodshot watery eyes, slow mumbled and slurred speech, flushed red face, and the strong obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance.

DRIVER STATEMENTS:

Neves said she was coming from "Brass Well", which was later determined to be Pirate's Well. Neves admitted to consuming alcohol on this night, however was unable to specify how much nor what they were.

ODORS: Unknown alcoholic beverage

Walk and Turn

During the instructions, Neves had difficulty getting into and maintaining the starting position. Neves also started the exercise prior to being told to do so. During the exercise, Neves missed heel-to-toe on multiple steps. Neves took 17 steps, rather than nine. Neves completed an improper turnaround by way of coming off the line. During the return, Neves again missed heel-to-toe on multiple steps and took 16 steps rather than nine.

One Leg Stand

During the exercise, Neves raised her right foot. Throughout the exercise, Neves was swaying and not counting aloud. Neves also raised her arms more than six inches from her sides and placed her foot down prior to being told to do so.

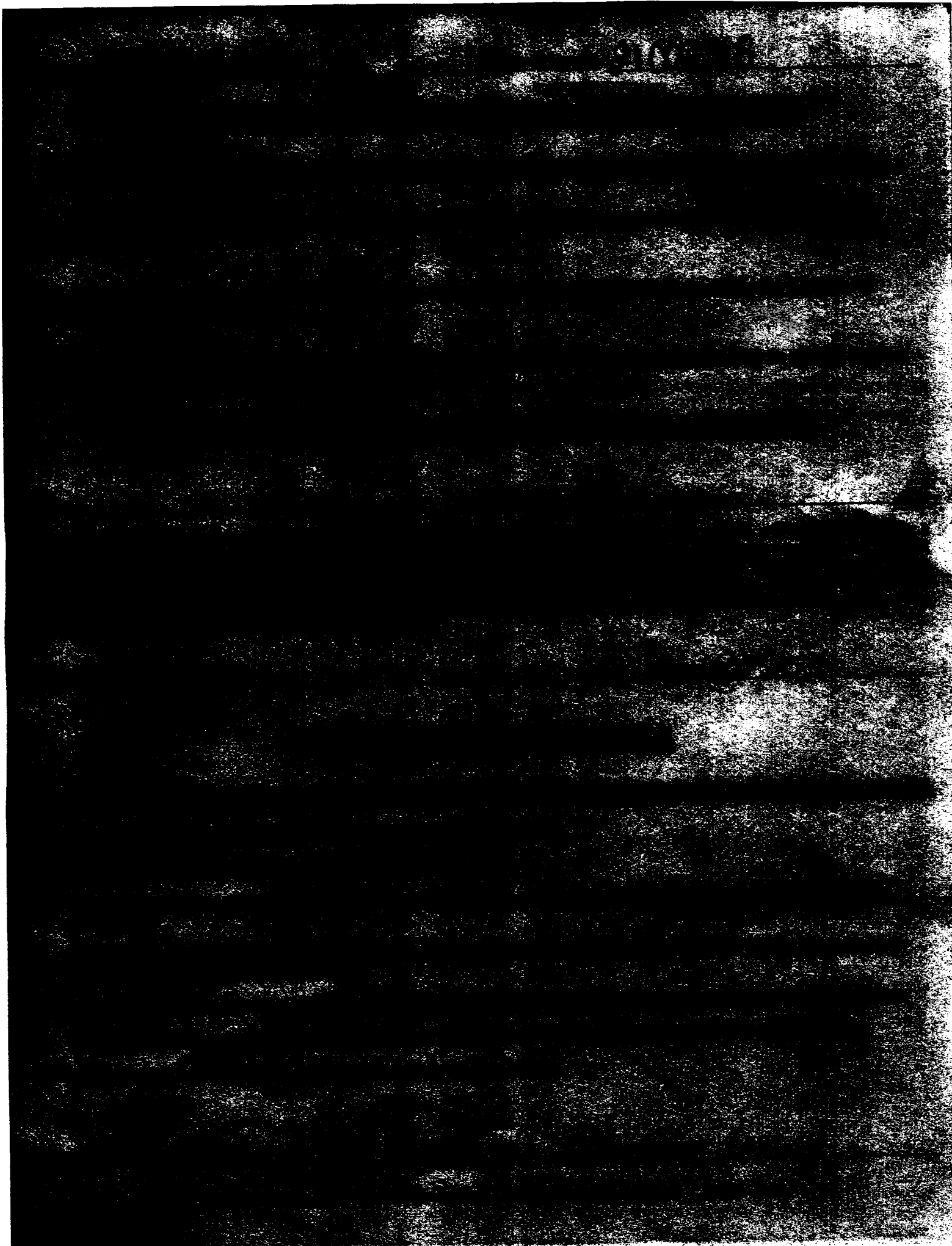



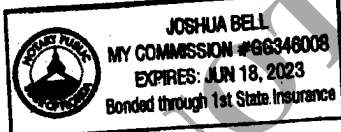
