The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/20/2020, at approximately 0358 hours, at the intersection of Culbreath Rd and Bloomingdale Av, Sgt. Roberts #117035 contacted the defendant on a single vehicle crash call for service while patrolling the area. Sgt. Roberts observed a white SUV parked on the sidewalk facing east as the sidewalk was north and south. The vehicle had struck a metal guardrail estimated at \$1000. Sgt. Roberts observed the defendant behind the wheel of the SUV while the vehicle was still running and the key around her neck attached to a lanyard. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI and refused to provide a breath sample. I advised the defendant of the Implied Consent warning in CB-01 room in CBT, where she still refused (see video). Subsequently, I completed the Affidavit Of Refusal To Submit To Breath Test. The defendant was positively identified via a Florida DL photograph.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
