This incident occurred in the City of Delray Beach, Palm Beach County, FL. On 05/07/2022, at approximately 2233 hours, I responded to 1045 E Atlantic Ave (Delray Hideaway) regarding an aggravated battery with a deadly weapon. Upon arrival, officers made contact with victim: Scott Blair; witnesses: Michael Guerra, Samantha Stewart and, Dallas Henninger; and defendant: Chad Gardner. Stewart and Henninger advised the following: they were sitting at an outdoor patio table with their significant others when Gardner approached them and started attempting to talk to them. They asked him to leave them alone however, Gardner did not. At some point, Gardner threatened to use bear mace but they did not see it. They then separated themselves from Gardner and went inside to use the restroom. When they returned, they incident had already occurred. Guerra advised the following: on this date, he observed as Gardner became increasingly agitated and belligerent inside of the establishment. Other patrons asked him to step outside and leave. Gardner walked outside and started becoming belligerent with female patrons outside while unlocking his bicycle. He heard as Gardner threatened them with bear mace. He then observed as Blair approached Gardner to help him clear out chairs for him to be able to take his bicycle out. Gardner then took a folding pocketknife from his person (Guerra motioned to his waistband area) and started aggressively advancing towards Blair. Gardner and Blair then engaged in a physical altercation. Guerra observed as Gardner stabbed Blair and Blair punched Gardner in self-defense. Blair advised the following: on this date, he was sitting out on the establishment's patio when Gardner came outside. Gardner then started unlocking his bicycle and he stood up to help clear out chairs. Gardner was belligerent and he observed as he pulled out a knife and started advancing towards him. As Gardner lunged his knife-wielding hand

P R O B A B L E C A U S E S T A T E M E N T	towards him, he was able to stop him, block him and then proceeded to punch him in the face in self-defense. They then fell to the ground in a scuffle, and he felt a sharp pain on his left side. Several other patrons then grabbed Gardner off of him and held him back until police arrival. Blair sustained a laceration to his left side and bruising to his right-hand knuckles. Gardner sustained injuries to his face. DBFD responded (Run #22-6277), treated Blair for his injuries and transported Gardner to Bethesda Hospital for further medical treatment. Once medically cleared for jail, Gardner was transported to PBCJ. Ofc. Mintus located the knife - this was later placed into Evidence. Sgt. Saraceni and I located Gardner's backpack - during a prisoner inventory for jail a 12oz can of bear mace spray was located - this was later placed into Evidence. Crime Scene responded for photographs. No employee was able to access camera footage at the time of the incident. For verbatim sworn statements of victim, witnesses and defendant refer to BWC footage. Based on the above stated facts, Probable Cause exists to charge the defendant, Chad Gardner, with one count of Aggravated Battery w/ a Deadly Weapon in violation of FSS 784.045(1A2).
