The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was driving a gray 2020 Alfa four door bearing a Florida license plate of 55EYW. He entered the Crosstown Expressway to travel eastbound from S Willow Ave and was paced traveling at 69 MPH in a 55 MPH zone and was weaving back and forth. This speed was paced for about half of a mile with my calibrated and certified vehicle #5050. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, slow and sluggish movements and reactions, unsteady stance, and an admission to consuming alcohol (three 16 ounce Heineken beers). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his FL DL.
