The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 5/30/2021, at approximately 12:25 pm, I (Trooper Angelicchi) traveled south on I-75 (SR 93A) at mile marker 253. I observed a grey Chevy Malibu and a black BMW 750 pass me on the right at high rates of speed. I was able to overtake the suspect vehicle and pace them at approximately 125 miles per hour in a posted 70 mile per hour zone. While following the suspect vehicles, I observed them cutting in and about of traffic and appear to be racing. When I overtook the vehicles, the grey Chevy Malibu traveled at 115 miles per hour, and the black BMW was on the right at the same speed. I observed the BWM point back at me and give the other suspect driver of the Chevy the middle finger, then take off at a high rate of speed again.

I overtook the black BMW again and activated my emergency equipment. The black BMW pulled over immediately, and I attempted to signal to the Chevy to stop. However, the Chevy took off again at a high rate of speed traveling south on I-75. I observed a large white male in the driver seat of the suspect vehicle (black BMW) and placed him under arrest for Racing and Reckless Driving. The arrestee was positively identified by his FL DL as CHAD RICHARD COHEN S (DOB: 3/9/1971). The above offenses occurred in Hillsborough County, FL.
