UPON MAKING CONTACT WITH THE DEFENDANT I OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE THAT HER EYES WERE BLOOD SHOT AND WATERY AND I COULD SMELL THE OBVIOUS ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HER MOUTH THAT WOULD GROW STRONGER WHEN SHE SPOKE. SHE ADMITTED TO COMING FROM A LOCAL BAR AND TO HAVING CONSUMED ALCOHOL PRIOR TO DRIVING. THE DEFENDANT CONDUCTED SFE'S IN WHICH SHE EXHIBITED SEVERAL MORE SIGNS OF IMPAIRMENT AND WAS PLACED INTO CUSTODY FOR DUI. 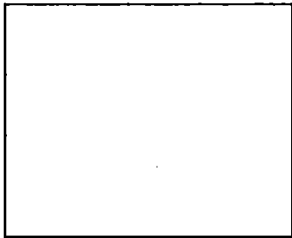
