The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a black 2015 Lexus IS250, 4 door, Florida tag CINY99. The defendant stopped his vehicle so that it was beyond the painted white stop line at a steady red traffic light. The defendant then made a right turn from a middle through lane rather than using the lane closest to the curb in the direction of his turn, thereby crossing over the outer right lane. The defendant's vehicle entered into a clearly marked painted yellow median and drove through this painted median. The defendant drove in a manner in which the vehicle tires crossed onto the outer painted lane markers multiple times, and drifted over the center painted lane line so as to briefly straddled the lane line as he made a left turn. A traffic stop was conducted to check on the defendant's welfare and determine if he were sick, tired, or impaired. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and his speech was moderately slurred. The defendant stated that he drank 4 or 6 beers throughout the day. The defendant displayed mild cognitive problems as he was easily distracted and was forgetful as related to requested documents. The defendant swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant refused to submit to a lawful test of his breath after he was advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
