The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 The defendant was driving a 2019 white Chevy pickup truck bearing a Florida license plate of LTWY65. He was traveling east on Kennedy from Henderson and accelerated at a high rate of speed. I followed the vehicle and observed it weaving back and forth in the lane then make a left turn onto N Arrawana Ave from the number one east bound lane (he failed to utilize the dedicated turn lane). The vehicle then pulled to the side of the road at North A St and struck a large concrete drainage culvert. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an unsteady stance, he stumbled several times. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant only performed HGN and the walk and turn then refused any other SFSEs. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his FL DL.
