Probable Cause

On September 26, 2021 I was on duty at the Breakers Hotel located at 1 South County Road, Palm Beach FL, 33480. While on duty at the restaurant area of the hotel I was made aware of two intoxicated persons that was attempting to enter an area that was closed to the public. Breakers Hotel security approached the two persons and asked them to leave the area. The persons were later identified as Charles McKolay and Maren McKolay. Mr. and Mrs. McKolay then proceeded to leave the restaurant area and stopped in the lounge area. Mrs. McKolay then took off her shoes and told the security officer, "Fuck You." I then approached her and asked if she was a guest at the hotel and if she was staying at the hotel. She stated that herself and her husband were staying at the hotel. I then identified myself to her as a police officer and told her that they both need to go to their room. Mr. Mrs. McKolay both had bloodshot glassy eyes, slurred thick speech and had the odor of an unknown alcoholic beverage emitting from their breath as they talked. She then began to get loud and continue to make a scene and disturb the peace in a public area. Mr. McKolay then began to ask what the problem was, and I told him to go to his room. I also identified myself again to Mr. and Mrs. McKolay. They were both then given a lawful order to leave the area and return to their room. Mr. McKolay then put his hand on my left shoulder and I told him not to touch me and go to his room. He refused to leave the area and I slightly pushed Mr. McKolay away from me as he was still touching me. He then pushed me, and I then took him down to the ground and placed him under arrest and in handcuffs. Mrs. McKolay then walked up to me as I was effecting the arrest on Mr. McKolay. She then tried to pull me away from Mr. McKolay and I then pushed her away from me. Mr. McKolay was then taken to my patrol vehicle outside in the parking lot. As I was trying to assist Mr. McKolay on the ground, she approached me again and tried to pull me away again. I then pushed her back away from me and then
