The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was driving a blue 2010 Lexus SUV bearing a Florida license plate of KJQ1R. She was traveling north on Howard Ave near Kennedy Blvd and was driving without headlight and tail lights on. A traffic stop was made and the defendant was slow to stop, then striking the curb when she stopped. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (three glasses of wine). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the implied consent warning.

The defendant was identified by her FL DL.
