On the **16** day of **February** 20**20** at **4:21** A.M. P.M. (Specifically include facts constituting cause for arrest.)

On 02-16-2020, as a Deputy Sheriff assigned to PBSO's District 14's (City of Lake Worth Beach) road patrol, I was dispatched to a call for an domestic dispute in progress at 1905 Lake Worth Road Apt #3, Lake Worth Beach, FL 33461. While walking to the residence I observed the suspect, Chelsea Ann Pizzi W/F, DOB: 09/06/1990 strike victim, Jessica Marie Kuperman W/F, DOB: 09/17/1988, with an open hand while they were outside of the apartment.

Both parties ran into the apartment when they saw me coming to the apartment complex. When Kuperman answered the door she was upset. I had Kuperman leave the residence and stand by with D/S Carey while myself and D/S Dunn entered the apartment to talk to Pizzi. At this time, D/S Carey advised that there was a gun inside the house that belonged to Kuperman. When I approached Pizzi, she was just about to get into the bath. Pizzi was uncooperative and crying. At approximately 16:21 hours, myself and D/S Carey, detained Pizzi due to there being a gun in the house and she was pacing around, not following commands to stop moving. The cuffs were double locked and checked for tightness. Myself and D/S Carey brought Pizzi to the marked patrol car where she was placed in the back seat and seat belt placed on.

I also observed the Kuperman with red finger marks behind her neck, left ear which was red and swollen, and red marks on the front of her neck. She could not advise how she go her injuries. Kuperman stated that her and Pizzi just returned from CRW Bar. At this time Kuperman questioned Pizzi about her talking to her ex, which is when they began to argue. Kuperman mentioned, that she made sure to remove the magazine from her Glock 43X 9MM Handgun in fear that Pizzi would want to harm herself. This was when Kuperman said Pizzi grabbed the gun, ran outside in her bra and underwear, and threw the gun outside. She stated, that was right before we arrived.


Pizzi was placed under arrest and I advised her of her Miranda Warning, at which time she declined to answer or speak.

Pizzi was transported to PBSO District 14.

Based on my investigation, I believe Chelsea Pizzi to be in violation of Florida State Statute 784.03 (1a1) Domestic Battery.
