On Sunday April 17th, 2022, at approximately 1848 hours I responded to 789 W Yamato Rd Boca Raton FL 33431 in reference to a disturbance. Upon my arrival, contact was made with the victim Nekiah Johnson. According to Nekiah, she and her friend Shawn Davis were driving a black Chrysler looking for a parking space inside of the residential parking garage. While looking for a parking space, Nekiah advised that a white female who was driving a black Infiniti behind her began to yell at them for taking a long time to choose a parking space. Shawn exited the driver seat of his vehicle to contact their friend Gene Schwartz who was standing in the parking garage awaiting Nekiah and Shawn's arrival. After exiting the vehicle, Shawn began to ask Gene where the best place to park would be. The W/F in the black Infiniti began to yell at Nekiah who was still in the passenger seat of the vehicle. Nekiah then exited the vehicle and began shouting back at the W/F. The W/F in the black Infiniti continued to yell at Nekiah for blocking an available parking space. According to Nekiah, she began walking over to the black Infiniti when she was approached by a short white female who slapped her in the face. Nekiah described the W/F to be approximately 4'8 weighing 100lbs wearing a white shirt and blue jean shorts. Contact was then made with the W/F who was driving the black Infiniti, Gina Alvarez. Gina stated that she was waiting for the back Chrysler to move into a space and became frustrated with the wait. Gina advised that she and Nekiah began shouting obscenities at each other when Nekiah ultimately exited her vehicle and began walking towards the Infiniti. Gina stated that her daughter, Chelsea Alvarez was in a silver vehicle behind her when she saw Nekiah approach the vehicle. According to Gina, her daughter Chelsea walked over to Nekiah and slapped her in the face for calling Gina a, "cunt and a Karen". Gina proceeded to call 911 following the altercation.

Chelsea stated that Nekiah called her mother a, "cunt, Karen and a bitch". After hearing the yelling, Chelsea observed Nekiah exit her vehicle and approach Gina's vehicle. According to Chelsea, when initially asked what happened, she spontaneously uttered, "I hit her in the face", referring to slapping Nakiah. Based on the above information, there is probable cause to believe that Chelsea Alvarez battered Nekiah Johnson pursuant to F.S.S. 784.03 Simple Battery. 1A1
