D.U.I. PROBABLE CAUSE AFFIDAVIT

ON THE 8th DAY OF October 2020 AT 21:50 A.M P.M.

PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:

On 10/08/2020 at approximately 2141 hours BBPD received a call in regards to a drunk driver traveling northbound on Ocean Pkwy in a brown Nissan Rouge. The caller who wished to remain anonymous advised that w/f Chesney Starnes walked into where she resides at 3265 Ocean Pkwy and left shortly after in her vehicle (BBPD CAD20-079856) . The caller advised that the female appeared intoxicated from alcohol. She then said that Starnes left in her brown Nissan Rogue and travelled northbound. Upon my arrival in the area I observed a Brown Nissan Rogue bearing TN tag 8P83J7, travelling north on Ocean Pkwy at the intersection of N Palm Dr. There is a posted stop sign at that intersection, which the vehicle failed to stop for. I began to safely follow the vehicle as it travelled north where it then travelled east on Mentone Rd. I paced the vehicle at 35MPH on a 25MPH residential street. As the brown Nissan Rogue travelled east on Mentone Rd it failed to maintain a single lane and was swerving all over the road. At which point, the Nissan turned into 1179 Mentone Rd. I activated my emergency equipment and made a driver side approach. I then made contact with w/f driver and sole occupant Chesney Starnes. I asked Starnes about her driving and the reason for my traffic stop. I asked Starnes if she knew the home owners to which she pulled into which she advised that she didn't. I asked Starnes for her Driver's License which she told me she didn't have it on her. While speaking to Starnes, every time she spoke, I could smell alcohol and the more she spoke the more it intensified. I asked Starnes if she had consumed any alcoholic beverages which she advised that she hadn't. I asked Starnes to step out of the vehicle, which she did. Once Starnes was out of the vehicle, I could tell that she was fidgety and her eyes were glossy. I could still smell the strong odor of alcohol every time she spoke. I once again asked Starnes if she had been drinking alcohol or had any narcotics which she answered no.

I started an investigation of Starnes possibly being under the influence while operating a motor vehicle. Starnes was asked if she recently had any disabilities or injuries which she replied that she didn't. Starnes told me that she wore eye contacts but did not have any issues with her vision. I asked Starnes if she would submit to a series of Standard Field Sobriety Tasks (SFST's) which she advised that she would.

The first exercise was the Horizontal Gaze Nystagmus. The task was demonstrated and Starnes advised that she understood it. Starnes was placed in the starting position of standing up straight with feet together and arms by her side and to keep her head still. Starnes swayed front to back during the exercise. Starnes had a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and onset of Nystagmus prior to 45 degrees in both eyes. Vertical Gaze Nystagmus was not present during the exercise.

HORIZONTAL GAZE NYSTAGMUS:

- Left eye does not follow smoothly
- Left eye prior to 45 degrees
- Distinct jerking in left eye at maximum deviation

- Right eye does not follow smoothly
- Right eye prior to 45 degrees
- Distinct jerking in right eye at maximum deviation

WALK AND TURN:

The second exercise was the Walk and Turn. The task was demonstrated and Starnes advised that she understood it. Starnes struggled to maintain balance while in the ready position. Starnes walked more than nine steps and did not count the steps out loud. When returning, Starnes did not conduct a proper turn. Starnes was unable to keep feet heel to toe while conducting steps.

ONE LEG STAND:

The third exercise was the One Leg Stand. The task was demonstrated and Starnes advised that she understood it. Starnes was lost balance during the exercise and had trouble balancing herself in the ready position. Starnes did not count like instructed. Starnes did not raise her feet as instructed and shown.

FINGER TO NOSE:

The fourth exercise was the finger to nose. The task was demonstrated and Starnes advised that she understood it. Starnes used the wrong finger once.

ROMBERG/ALPHABET:

Based on the initial indicators that I observed on scene during the encounter and the indicators that I observed during the SFST exercises, I placed Starnes under arrest for DUI (316.193 1 A).

I then transported Starnes to PBCJ. I arrived at the facility at 2221 hours and I started my 20 minutes observation at 2224 hours and completed at 2244 hours. Upon completion I requested Starnes to provide a sample of her breath to determine the alcohol content, which she refused. Starnes was read implied consent due to her refusal to provide breath. A refusal was determined for Starnes at 2245. Starnes was read her Miranda Rights which she advised she understood. Starnes was read instructions to Questions & Answers. Starnes would not answer any questions. Starnes further refused to answer after given multiple chances. While at PBCJ, Starnes refused to sign the DUI citation. An additional citation for refusal was provided with a court date. Starnes was also cited for careles driving.

Incident was captured via BWC. Starnes vehicle was removed from scene by Beck's Towing.


