The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 14 day of JUNE, 2020, at approximately 4:15 PM, at SKYWAY NORTH PIER, in Pinellas County did:

DID THEN AND THERE INTENTIONALLY AND UNLAWFULLY THREATEN TO DO VIOLENCE TO JOSEPH PUGLISI, WESLEY WOMACK, AND DANIEL TOLENTINO WHILE HAVING THE APPARENT ABILITY TO CARRY OUT SAID THREAT AND DID CREATE A WELL FOUNDED FEAR IN JOSEPH PUGLISI, WESLEY WOMACK, AND DANIEL TOLENTINO THAT SUCH VIOLENCE WAS IMMINENT AND IN THE COMMISSION OF SAID ASSAULT DID USE A DEADLY WEAPON, TO-WIT: A KNIFE, A BETTER DESCRIPTION OF WHICH TO THE STATE ATTORNEY IS UNKNOWN, BY DISPLAYING THE KNIFE AND APPROACHING THE VICTIMS IN AN AGGRESSIVE MANNER AFTER A VERBAL ALTERCATION, THE DEFENDANT AT THE TIME OF THE ASSAULT NOT HAVING THE INTENT TO KILL JOSEPH PUGLISI, WESLEY WOMACK, AND DANIEL TOLENTINO.

THE DEFENDANT ENTERED INTO A VERBAL ARGUMENT WITH VICTIM DANIEL TOLENTINO REGARDING HOW THE VICTIM HAD PARKED HIS VEHICLE ON THE FISHING PIER. WITNESSES STATED THAT THE DEFENDANT USED MULTIPLE RACIAL SLURS AS HE SHOUTED. THE DEFENDANT THEN ALLEGEDLY SPIT ON MR. TOLENTINO. THE OTHER TWO VICTIMS, JOSEPH PUGLISI AND WESLEY WOMACK, SAW THIS AND APPROACHED THE DEFENDANT, WHO THEN ALLEGEDLY THREW A BEVERAGE CAN AT PUGLISI AND WOMACK. THE DEFENDANT THEN RETURNED TO HIS VEHICLE, WOMACK AND PUGLISI FOLLOWING ON FOOT. THE VICTIMS STATED THAT THE DEFENDANT BEGAN DRIVING FORWARD, BUT THEN STOPPED ABRUPTLY. PUGLISI THEN FELL FORWARD, RESULTING IN HIS ARM GOING THROUGH THE REAR WINDOW OF THE DEFENDANT'S VEHICLE. THE DEFENDANT STATED THAT HE HAD NOT STOPPED SUDDENLY, BUT THAT PUGLISI INTENTIONALLY STRUCK HIS WINDOW. DESPITE THE PIER AHEAD OF THE DEFENDANT'S VEHICLE BEING OPEN TO DRIVING AWAY TO A SAFER LOCATION, THE DEFENDANT CHOSE TO REMAIN, AND EXITED HIS VEHICLE TO CONFRONT THE VICTIMS. UPON EXITING HIS VEHICLE, THE DEFENDANT DISPLAYED IN HIS HAND A KNIFE, WHICH HE LATER STATED WAS FOR HIS OWN DEFENSE.

NOTE: INJURIES SUSTAINED BY MR. PUGLISI WERE TO THE RIGHT FOREARM (NOT THE FIST OR KNUCKLES), A RESULT OF CONTACT WITH THE REAR WINDOW, NOT THE KNIFE WIELDED BY THE DEFENDANT.

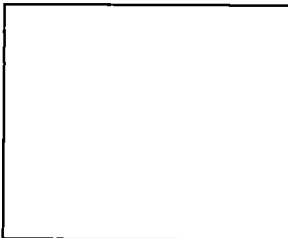
