	SAMANTHA LONG MET WITH ME AND STATED HER HUSBAND CHRISTIAN LONG VIOLATED AN INJUNCTION AGAINST COMMITTING ACTS OF DOMESTIC VIOLENCE (50-2021-DR-009079-XXXX-NB) WHICH WAS SERVED ON 11/04/2021 AND IS IN EFFECT UNTIL 11/04/2022. ONE OF THE RESTRICTIONS (SECTION III, PARAGRAPH 3, PART C) STIPULATES HE "SHALL NOT HAVE IN HIS CARE, CUSTODY, POSSESSION OR CONTROL ANY FIREARM OR AMMUNITION." THE INJUNCTION ALLOWS FOR A TEMPORARY PARENTING PLAN BETWEEN THE PETITIONER SAMANTHA LONG REGARDING THEIR SON (DOB: 10/19/2019).											
	ON 2/5/2022, CHRISTIAN LONG HAD CUSTODY OF AND THEY WENT TO "OUTDOOR YOUTH DAY" AT THE EVERGLADES YOUTH CAMP IN THE J. W. CORBETT WILDLIFE MANAGEMENT AREA. THE EVENT OFFERED VARIOUS STATIONS WHERE THE YOUTH WERE INTRODUCED TO SHOOTING .22 CALIBER RIFLES, SHOTGUNS, MUZZLE-LOADING FIREARMS, AND ARCHERY. SAMANTHA SHOWED ME A PRINTED PICTURE FROM HER CELL PHONE DATED FEBRUARY 5TH WHICH PORTRAYED CHRISTIAN LONG HOLDING A BLACK BOLT ACTION RIFLE IN A PRONE SHOOTING POSITION WITH LYING WITH HIM. CHRISTIAN WAS HELPING HOLD THE FIREARM AND SIGHT DOWN THE BARREL. THEY BOTH WORE HEARING PROTECTION AND GLASSES. SAMANTHA SAID CHRISTIAN HAD POSTED THE PICTURE ON A SOCIAL MEDIA SITE, BUT HE REMOVED IT A SHORT TIME LATER.											
	BASED ON THE PICTURE, THE VERBAL AND SWORN WRITTEN STATEMENTS MADE BY SAMANTHA LONG, AND MY INVESTIGATION INTO THE OUTDOOR YOUTH DAY EVENT, I HAVE PROBABLE CAUSE TO BELIEVE CHRISTOPHER LONG WAS IN POSSESSION AND CONTROL OF A .22 CALIBER BOLT-ACTION RIFLE AND AMMUNITION FOR THE FIREARM AFTER HAVING BEEN ISSUED A FINAL INJUNCTION THAT IS CURRENTLY IN FORCE AND EFFECT, RESTRAINING HIM FROM COMMITTING ACTS OF DOMESTIC VIOLENCE, WHICH MEETS THE ELEMENTS OF F.S. 790.233(1).
