

<p>The Victim in this Case Invokes Marcy's Law</p> <p>On Friday, August 20, 2021 at 2257 Palm Beach Police Communications received a 911 call from a security officer at 360 South Ocean Blvd. (Dunster House). The caller reported that a female had a verbal altercation with her boyfriend at [REDACTED]. The caller reported that the male subject pushed the female out the door and onto the ground.</p> <p>Upon Arrival, I met with Christie Ann Lemieux-Gannon, (W/F, D.O.B. 02/13/1976). Gannon stated she was laying in bed naked with her boyfriend, [REDACTED] (Alleged Suspect) when she asked him to go down stairs to retrieve her cell phone. Gannon stated when [REDACTED] returned to the bedroom a verbal altercation began. Gannon stated [REDACTED] demanded Gannon to leave his residence and began pushing her out the front door. Gannon stated since she did not have any cloths on, she fought to get back inside to get cloths and grab her personal belongings. Gannon stated during this struggle, [REDACTED] pushed her onto the ground. It should be noted that during this interview, I observed Gannon to be wearing a white dress with a green grass mark on her left knee. Gannon insisted that during the entire altercation she was naked and that Gannon had thrown her on the ground.</p> <p>After taking Gannon's initial statement, Myself, Sgt Bates and Officer Singer responded to [REDACTED] ([REDACTED]'s residence). Upon making contact with [REDACTED], he had a conflicting version of what had transpired. [REDACTED] stated he and Gannon have had an on and off [REDACTED] for approximately 3 years. [REDACTED] stated Gannon has a drinking problem and becomes belligerent when she is intoxicated. [REDACTED] stated he and Gannon were laying in bed naked, about to go to bed when Gannon had to use the bathroom and asked [REDACTED] to get her cellphone. [REDACTED] stated he went down stairs and retrieved Gannons cell phone, during which time a man called her phone. [REDACTED] stated this</p>

agitated him, causing a verbal argument to ensue. [REDACTED] stated he then began texting Gannon's juvenile daughter, (12 years old) and asked her to have Gannons mother come pick up Gannon, due to her being drunk and aggressive. Ultimately, [REDACTED] stated when the incident became physical, is when Gannon was dressed, near the front door of the residence and he was trying to give her a ride home. [REDACTED] stated Gannon was refusing to leave, during which time she grabbed his face and forcefully took his eye grasses. This forcefulness caused [REDACTED] to have a small scrape/cut on the brow of his nose. [REDACTED] stated he then acted in self-defense and grabbed Gannon by both wrists to stop her. [REDACTED] advised he did not push her to the ground. [REDACTED] stated Gannon then proceeded to leave on foot and walk eastbound, towards South Ocean Blvd. [REDACTED] gave permission to copy his text messages that he had to send via his tablet, as Gannon had hid his cell phone. The text messages told the same chronological story he explained.

It should be noted that the scratches and bruises are consistent to that of a fall on the roadway or the two steps made of rough coral leading to the front door of [REDACTED]. Upon re-interviewing Gannon, she repeated parts of her first statement, but then began to contradict parts of her story. When asked about the green grass mark on her knee she appeared shocked and did not know she had it. Gannon then contradicted her original statement and said that she had clothing on during the altercation when [REDACTED] pushed her to the ground.

Based on the above facts and text messages provided on scene, Gannon was deemed the aggressor and was placed under arrest and charged with one count of Domestic Simple Battery, Pursuant to F.S.S. 784.03. Both parties denied medical treatment.

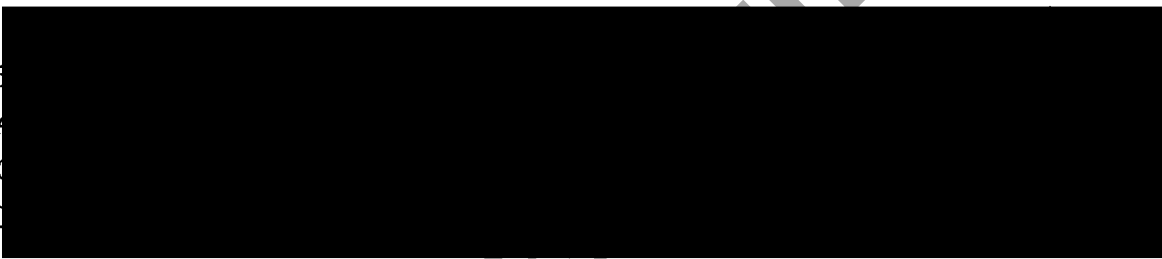
