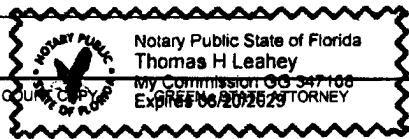

(Specifically include facts constituting cause for arrest.)</p> <p>On 03/26/2020 at approximately 2100 hours, I responded to 1401 Pinecrest Cir. in the Town of Jupiter, Palm Beach County, FL in reference to a motor vehicle crash. At the time, I was driving an unmarked Jupiter Police Department patrol vehicle (vehicle 1916), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.</p> <p>Upon arrival, I observed a white 2014 Ford Escape bearing FL tag # IE46RF stopped, straddling a grass area between two parking spaces outside the aforementioned address. The vehicle was stopped, completely in the bushes, with the front bumper against a palm tree. The bushes had been snapped and broken and there were multiple scratches to the vehicle. I observed a white female standing outside the vehicle, who I identified to be Christie Galasso (w/m; 02/25/1978) by her US Passport. I made contact with a witness to the crash, Tracy Pascarella (w/f; 01/22/1962), who advised she witnessed the crash and identified Galasso as the driver of the vehicle at the time of the crash. Pascarella provided a recorded witness statement to officers on scene.</p> <p>I then made contact with Galasso who was extremely unsteady on her feet, was verbally defiant, and had the odor of an unknown alcoholic beverage on her breath. During my contact with Galasso, she had mood swings and appeared to be under the influence to the extent that her normal faculties were impaired. Galasso progressively became more and more uncooperative as the investigation continued.</p> <p>I collected the information necessary to complete the crash investigation, returned to Galasso, advised her the crash investigation was over and I was starting a criminal DUI investigation. I advised Galasso of her Miranda Warnings and confirmed she understood each one. I requested Galasso complete Standardized Field Sobriety Tasks (SFSTs) and she refused. I advised Galasso of her Taylor Warnings and again asked her to complete SFSTs. Galasso agreed.</p> <p>I asked Galasso to take a step away from her vehicle and she complied. I attempted to begin SFSTs (Horizontal Gaze Nystagmus) and Galasso became verbally uncooperative, talking over me and not allowing me to provide her with the instructions. I attempted to advise Galasso that, if she continued to talk over me I would consider her behavior a refusal to complete the tasks. Galasso advised she was not refusing to complete the tasks and stated she wished to continue. Despite this claim, Galasso continued to talk over me making it completely impossible for me to provide her with instructions without screaming at her and I determined she did not wish to continue.</p> <p>I placed Galasso under arrest for DUI - Damage to Property and secured her in handcuffs behind her back which were checked for proper spacing and double-locked to prevent tightening. Sergeant Drown (a female officer) responded to perform a search of Galasso's person.</p>

(Specifically include facts constituting cause for arrest.)</p> <p>While awaiting Sergeant Drown's arrival, Galasso became extremely verbally non-compliant in the rear seat of my patrol vehicle. Galasso advised the situation was "fucking crazy", was completely appalled that she was being arrested while the Coronavirus was plaguing the world, and spontaneously uttered (yelling) that she was only driving from her grandparents house back home. I also performed a driver license query of Galasso via the Driver and Vehicle Information Database (DAVID) and determined she did not have a driver license, but had a Florida driver license number assigned to her (FL DL # G420-101-78-565-0).</p> <p>When Galasso was searched, I transported her to the Palm Beach County Breath Alcohol Testing Facility. The entire ride to the BAT, Galasso was screaming to the point that I had to turn the music up to drown out her nonsensical, repetitive, and intoxicated rhetoric. Galasso complained several times that the music was too loud and I turned the music down, advising her that if she continued yelling, I would turn the music back up. Galasso could not go more than several seconds without the music playing before she again began yelling and arguing with me and the music was turned back up. I monitored Galasso's welfare via the prisoner camera mounted in the prisoner partition.</p> <p>After arrival at the BAT (during the observation period), Galasso continued to be verbally uncooperative advising she wished to tell the judge to "go fuck off", she stated that I was going to be "so fucked", that she was going to sue me, routinely demanding to know over and over and over again what she was arrested for, asking why she was handcuffed, demanding I take the handcuffs off, stating that she parked "in my own property, in my own bushes", repetitively asking if there was any evidence, demanding to complete a breathalyzer, and being extremely unpleasant. Despite her behavior, I conducted a 20 minute observation period to ensure Galasso did not ingest or regurgitate anything.</p> <p>When the observation period was complete, I requested Galasso provide a lawful sample of her breath for the purpose of determining the alcohol content. It should be noted that, as soon as Galasso entered the testing room, her demeanor changed for approximately 2 minutes and she was responding to my questions. After I initially requested Galasso provide a breath sample, she refused and I attempted to read her Implied Consent. Galasso would not listen and yelled continually while I was attempting to read her Implied Consent (excluding the CDL portion of Implied Consent). I asked Galasso if she understood and she continued yelling, not answering the question. Due to Galasso's continuous, uncooperative, and belligerent behavior, I determined she was ultimately not willing to provide a breath sample at 2248 hours.</p> <p>I secured Galasso in a holding cell with the handcuffs on due to her behavior while the arrest paperwork was complete. I asked Galasso multiple times whether or not she wished to sign her criminal citations for DUI and No DL. Galasso flopped between wishing to sign the tickets and not signing. Galasso repetitively questioned the DUI citation and I ultimately determined she did not wish to sign. She later yelled through the holding cell door "I'm not signing shit!"</p>

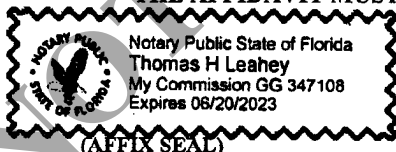

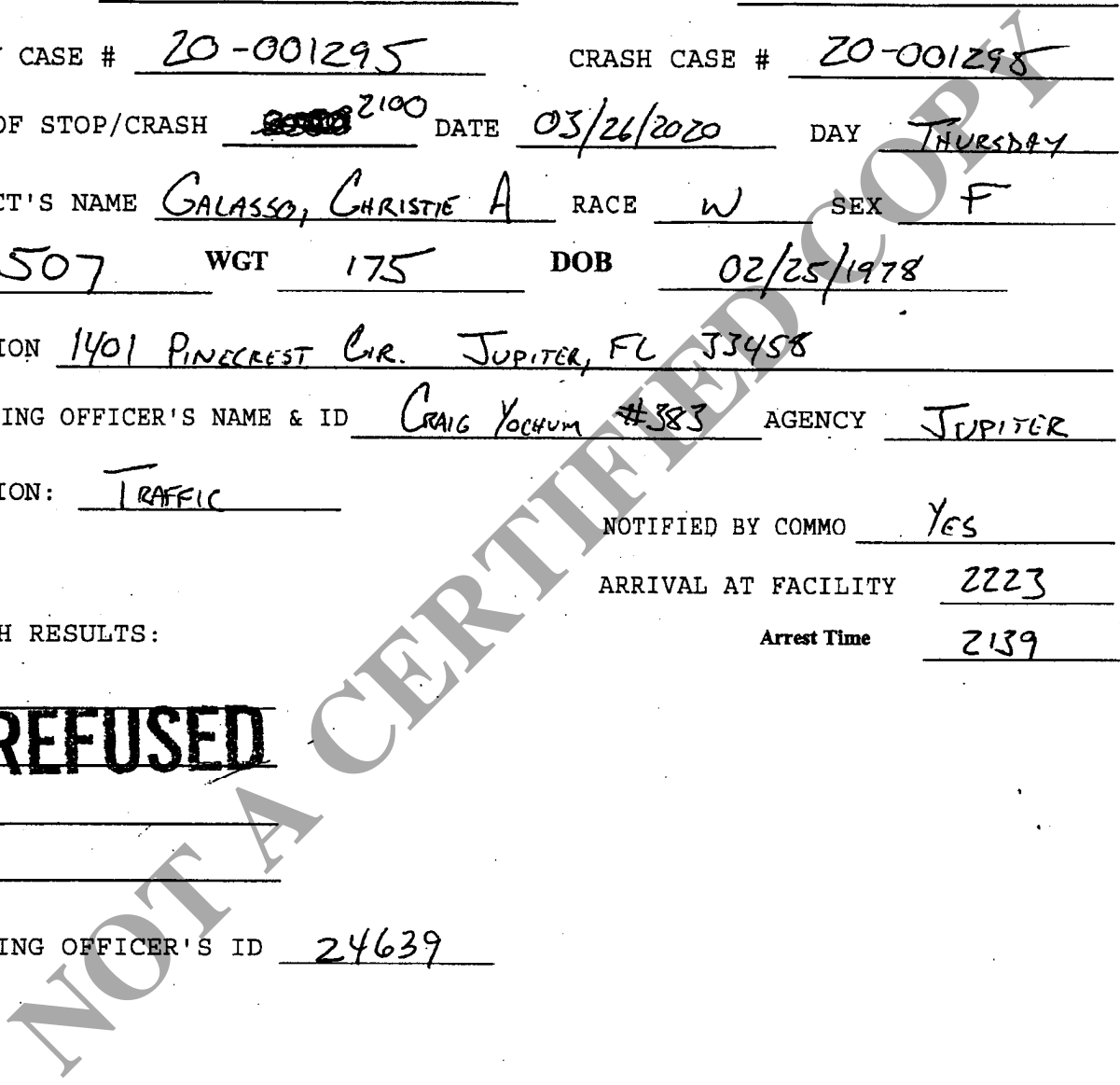
