The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time, at Gunn Hw / Sheldon Rd within Hillsborough County, Deputy D. Randall #244931 contacted the driver on a traffic stop for driving and crossing over on the median strip (citation #ADTDA6E). Deputy D. Randall observed the defendant in the driver seat and sole occupant of the vehicle. Upon contact with the defendant, she emitted a strong odor of an alcoholic beverage from her breath, she had slurred speech, and had bloodshot and watery eyes. The defendant refused to submit to the requested exercises after being advised that Field Sobriety exercises are voluntary, and that the exercises may dispel any suspicion of impairment and that her refusal to perform the requested exercises will be used against her in a court of law. The defendant was arrested for DUI based on the totality of the circumstances and refused breath test after Implied Consent warning was read and understood. The defendant was identified via DAVID.
