PROBABLE CAUSE

Before me this date personally appeared, Victoria Lima #643, who being first duly sworn deposes and says that on the 5th day of May, 2017 at 6750 SW 11 St, the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

The Def Christina Calsi and Def/ Barbara Hausler whom are mother and daughter and currently reside as a family were in a physical altercation Post Miranda Calsi advised that she was getting her kids ready for school and was spanking her daughter because she was disrespecting her and talking back Calsi advised that Hausler then came towards her as a crazy women and started yelling at her and began to hit her Calsi sustained injury to the left side of her face (bruising) as well as several cuts and abrasions to both of her hands

Post Miranda the Def Barbara Hausler advised that she asked Christina to turn off the lights and her daughter went crazy cursing at her, then spit in her face and hit her in the right side of her face with a closed fist Hausler sustained injury to the right side of her face very minor swelling bruising

Based on no independent witness and conflicting stories I am unable to determine the primary aggressor, as such both Calsi and Hausler have been placed under arrest and transported to BSO main jail for booking
