The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 11/26/19. law enforcement officers responded to the listed location in reference to drug information. Upon arrival, contact was made with the defendant and the co-defendant. The defendant had in her possession a black purse. The defendant gave consent to search the purse and within the purse was multiple small plastic straws, and one yellow pill that was identified as Alprazolam. The defendant spontaneously stated that she uses straws to snort her Xanax pills. The straws had white residue on it. The defendant did not have a doctor's prescription for the pills. The defendant was in possession of a pill case that contained one half blue pill that was identified as Amphetamine and Dextroamphetamine "Adderall". The defendant was also in possession of two yellow strips which were identified as Suboxone. These items were located inside the defendant's apron, which she was wearing at the time of the investigation. The defendant was in possession of a small clear plastic baggy with white residue inside which tested positive for methamphetamine (0.1g). The clear plastic baggy fell on the ground during a search of the defendant's person. The defendant was also within 1,000 feet of Madison Middle School, exact distance 101 feet (laser serial# UX002570). Post Miranda the defendant admitted to the crime and identified all the illegal substance in her possession. The defendant did not qualify for APAD program.
