The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was driving her 2018 white Infinity four door bearing a Florida license plate of GATV19 east in the 3200 block of W Fountain Blvd when she struck the victims vehicle which was unoccupied and parked in the road. The right front of the defendants vehicle struck the victims vehicle causing extensive damage (aprox \$15,000). The defendant then fled the scene of the crash without providing information. Your affiant was on MacDill Ave near Swann and observed the defendant traveling east on Fountain and then south on MacDill and was riding on what appeared to be the rim of the vehicle as sparks were flying off the pavement. A traffic stop was initiated and the defendant was later arrested for DUI under report 20-365872. The tire of the defendants vehicle came completely off and there were fresh marks in the pavement at MacDill and Fountain where I observed the defendant. These marks were traced back to the victim's vehicle which was only one block from this location and there was consistent paint transfer (and damage) on both vehicles.

The defendant was identified by her FL DL.
