The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a 2020 black Chevy four door bearing a PA license plate of LJF4561. She was traveling west on W Azeele St between Henderson and Dale Mabry and traveling over 50 MPH in a 40 MPH zone and was weaving back and forth. The defendant also failed to stop for a steady red light when making a right turn onto Dale Mabry Hwy and then was paced traveled over 60 MPH in a posted 40 MPH and was weaving back and forth. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .163 and .176.

The defendant was identified by her FL DL.
