The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On the above listed date, time, and location, the defendant and victim were engaged in a verbal argument. The victim had recently left the residence and spent some time with her parents which upset the defendant. The victim returned to the residence and attempted to get her dogs out of the defendant's room. A verbal argument ensued. The argument became physical when the defendant knowingly, willingly, and intentionally struck the victim in the face two times with a closed fist, against her will. The strikes caused swelling to the victims left eye. The victim declined medical attention at this time. I did not observe any injuries to the defendant at this time. The victim then left the residence and called law enforcement. The defendant and victim have been in a romantic relationship for approximately 5 years and have resided together for approximately 4 years together. They are not married and do not have any children in common. To my knowledge no other witnesses were present for the incident. The victim identified the defendant as the person who committed the offense via his name and birthday. I identified the defendant via his FL DL Photograph as: Christopher Ackman.
