The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a black 2021 Kia K-5 4-door (FL ATG #QGCM18) southbound on West Shore Blvd S at a high rate of speed, which I visually estimated to be at approximately 50 MPH. I then used MPH Sureshot Laser (serial #FL10006) to confirm an exact speed of 52 MPH at a distance of 442.6 feet. During the traffic stop for the speeding infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, dilated pupils, blank/dazed stare, avoided eye contact, confusion (he handed me his debit card for identification and was attempting to "get a quote" while looking for his insurance on google), appeared lethargic, body tremors, eyelid flutters, short term memory loss (repeated the same questions several times, forgetting that I had already answered them), slowed internal clock, and appeared very nervous/paranoid. Believing that he could be possibly physically impaired on cannabis, I asked the defendant to perform SFSEs, to which he was reluctant to, but complied. He was arrested for DUI following a poor performance during the SFSEs. While at CBT, the defendant provided a urine sample upon request.
