The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On this date, I was conducting a laser operation at Dale Mabry HWY and Osborne when I observed 3 vehicles traveling southbound at high rate of speeds. It was readily apparent they were all racing each other in an attempt to outgain or outdistance each other. I pulled out behind them and overtook them and paced clocked them at speeds of over 90 MPH in a 45 MPH zone. As I followed, all three vehicles cut in and out of traffic as they passed other vehicles on the roadway and they were all willfully trying to prevent each other from passing each other in a willful and wanton reckless manner placing other motoring public at risk. My in car video captured this entire incident and I radioed for help from other officers and MPO J. Blanchard and OFC A. Visser stopped all the vehicles at Spruce and Dale Mabry HWY.
