 On 11/16/2019, at approximately 2238 hours, in the Old Navy's parking lot which is located at 2400 Brandon Boulevard West, Brandon, Florida 33511 Deputy A. Jenkins ABN: 254209 observed the defendant operating and in physical control of a blue 2018 Tesla Model S bearing Florida tag KALH03 with an assigned VIN of 5YJSA1E4XJF257841. Deputy Jenkins responded to the scene reference a reckless driver call for service. Upon Deputy Jenkins' contact with the defendant and sole occupant of the vehicle, he observed multiple indicators of impairment.
