The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was involved in a traffic crash causing approximately \$100 in damage. The defendant was identified as the driver of a black Honda 4D bearing FL tag LPSA52 by the witness.
