On Saturday, June 20th, 2020 at approximately 0517 hrs I responded to a disturbance in progress complaint at 4282 Danielson Dr, in unincorporated Lake Worth, Palm Beach County, Florida, 33463.

While en route communications advised that they were land line with the complainant/victim who was verbally identified as Corey Forsberg who was advising that he had been struck in the head with a baseball bat by his land lord.

Upon arrival I met and spoke with Forsberg who advised that he had been struck in the head with a baseball bat by his landlord who is also his boyfriend of two years . Forsberg identified his boyfriend as Christopher Farron.

Forsberg advised that the altercation between he and Farron started at approximately 0200 hrs this morning when Farron woke him wanting to be intimate. Forsberg stated that he did not wish to be intimate which started a verbal altercation between he and Farron. Forsberg stated that Farron told him to get out, he advised that he began packing his belongings however Farron continued to argue with him at one point he stated Farron attempted to strike him with his walker. Forsberg advised that the altercation continued into this morning when Farron struck him on his left forearm with bat and twice in the head once on the left side and once on the right side. I observed injuries to the right side of Forsberg's head and to the left side of his head as well as a large bruise on his left forearm. D/S E. Cowart I.D. 30558 photographed Forsberg's injuries.

While speaking with Forsberg a Silver Mercury 4DR left 4282 Danielson Dr and proceeded north bound passing our location Farron was observed in the right front passenger seat of the vehicle as it passed by. D/S J. Babula I.D. 36173, D/S A. Cano I.D. 18733 of the Palm Beach County Sheriff's Office, and I conducted a traffic stop on the vehicle at which time Farron was detained. D/S A. Blake I.D. 9712 obtained a sworn written statement from Forsberg regarding this incident.

Upon speaking with Farron he stated that he and Forsberg have been in a intimate dating relationship for the past two years however they've been separated for six months, he stated that they recently got back together two days ago. Farron advised that they were involved in a verbal altercation earlier this morning during which time he stated that Forsberg pushed him. Farron advised that he told Forsberg to get out of the house however he would not. I inquired with Farron as to how Forsberg received his injuries at which time he stated that after Forsberg pushed him he struck him with the baseball bat. Farron stated that he only struck Forsberg because he pushed him, Farron denied striking Forsberg with his walker, however he advised that Forsberg did throw it across the room.

At this time based on my observations of Forsberg's injuries, and the sworn written statement provided by Forsberg there was probable cause for the arrest of Christopher Farron for aggravated battery with a deadly weapon contrary to F.S.S.
